This holds the date of your wedding exclusively, and is non-refundable. The balance is due not later than two weeks prior to the date of the wedding. All payments are due as described unless prepaid. If the event is cancelled within two months of the date, the client shall pay the balance of the contract due to the high probability that Rustic Dreams Photography LLC will be unable to rebook that date. **LIABILITY:** While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding events, Rustic Dreams Photography LLC's entire liability to the client's for any claim or loss arising from Rustic Dreams Photography LLC's performance is limited to a refund to the clients of the amount the clients paid for services. Because a wedding is an uncontrolled event, Rustic Dreams Photography LLC cannot guarantee delivery of any specifically requested image(s). In the unlikely event of personal illness or other circumstances beyond the control of Rustic Dreams Photography LLC, a

substitute photographer of equal or greater qualifications, subject to acceptance by the client prior to the event, may be sent to fulfill the obligations of this agreement.

**PHOTODISCS:** upon receipt of a photo DVD, client accepts all responsibility for archiving and protecting the photographs. Rustic Dreams Photography LLC does not permanently archive image files. Rustic Dreams Photography LLC is not responsible for the lifespan of any digital media provided or any future changes in digital technology or media readers that might result in an inability to read discs provided. It is client's responsibility to make sure that digital files are copied to new media as required.

**PRICING:** services or merchandise not included in this initial contract will be sold at current price when an order is placed. All prices are subject to change at any time without notice. Credit vouchers have no intrinsic cash value and may only be applied toward merchandise purchased from Rustic Dreams Photography LLC. All print/album credits must be used within 4 months of DVD delivery/web gallery posting or photographer may substitute a product of reasonable value to fulfill any outstanding credit.

**RESPONSIBILITIES:** unless agreed upon in advance, Rustic Dreams Photography LLC shall be the exclusive photographer retained for the event. Videographers and other vendors as well as semi-professional photographers must not obstruct or interfere with the official photography. Family and friends of the client are welcome to photograph the wedding as long as they will not interfere with Rustic Dreams Photography LLC's duties. Rustic Dreams Photography LLC is not responsible for compromised coverage due to causes beyond her own control such as other people's camera or flash, the lateness of the bride, groom, family members, and bridal party members or other principles, weather conditions, schedule complications, rendering of decorations, or restrictions of the venues or officiate. Rustic Dreams Photography LLC is not responsible for existing backgrounds or lighting conditions which may negatively impact or restrict the photography coverage. Client agrees to confirm the schedule two weeks prior to the event and to send the photographer a copy of the invitation prior to the wedding. Notification of any changes in schedule or location must be made in a timely manner. Changes can be made by phone with a follow-up email for

documentation. If email is sent, confirmation of receipt must be obtained. It is the clients' responsibility to schedule and receive permission to use various locations for photography, including the wedding and reception locations and any other locations used during the day.

**COVERAGE:** Rustic Dreams Photography LLC will provide coverage for the dates, locations, and continuous hours specified in this agreement. Additional travel or coverage hours may be added by agreement on wedding day and must be paid in full before any photos or products are released to the client. Every reasonable effort will be made to take requested pictures, but no specific pose or photograph can be promised. Any lists supplied will be used for organizational purposes only. Images determined by Rustic Dreams Photography LLC to be substandard or duplicated may be edited out. Rustic Dreams Photography LLC will use her professional judgment and sole discretion to select which photos to deliver. Such selection shall constitute all images that will be made available to client.

**IMAGE PROCESSING/PRINTING:** unless agreed upon prior to any editing work, high-resolution disc(s) and albums may contain a mixture of color, black & white, and selective color images. Limited changes requested by client are included at Rustic Dreams Photography LLC's discretion. Client may request further changes for an additional charge. Rustic Dreams Photography LLC is not responsible for any prints not ordered directly through her. For best results, clients should order their prints through a reputable lab. Digital processing takes approximately two weeks.

**MODEL RELEASE:** this contract serves as a model release giving Rustic Dreams Photography LLC the irrevocable right to use the photographs in all forms and in all media and in all manners, without any restriction as to changes or alterations, for advertising, trade, promotion, exhibition, or any other lawful purpose. Rustic Dreams Photography LLC can grant use of images to third parties and all compensation for use and credit for the images remain the property of Rustic Dreams Photography LLC. Client waives any right to inspect or approve the photograph(s), finished version(s) incorporating the photograph(s), or the use to which it may be applied, including written copy that may be created and appear in a

connection therewith. This release is binding on the client, their legal representatives, heirs, and assigns.

**COPYRIGHT:** all photographs taken by Rustic Dreams Photography LLC are her property, will remain her property, and are protected by United States Copyright Laws (USC Title 17). Client hereby waives any claims of ownership, income, editorial control, and use of the images. Violations of this federal law will be subject to its civil and criminal penalties.

**REPRODUCTION:** client has the right to scan, copy, and reproduce images provided for their personal use only and must not alter, sell, or publish the photographs. Client further agrees not to supply images to any third parties (including vendors associated with the wedding).
